The Story of One Battalion . . . the Thirty-Third

Perhaps the best starting point for the story of the 33rd (Special) U. S. Naval Construction Battalion is the Stevedore Pool at Camp Peary, Virginia. While waiting for assignment to a Special Battalion the men in the pool cut wood, drilled, or went on guard duty and other details. The deary winter months of 1943-'44 slowly passed, but green wood fought a losing battle against the chill of the Virginia nights. Colds and cat fever laid many low. In April the pool prepared to move to Rhode Island. Men were shifted from one barrack to another, got their hair cut short, and stood inspections. On April 15 and 16 the trains pulled out to the strains of "Carry Me Back to Old Virginnny."

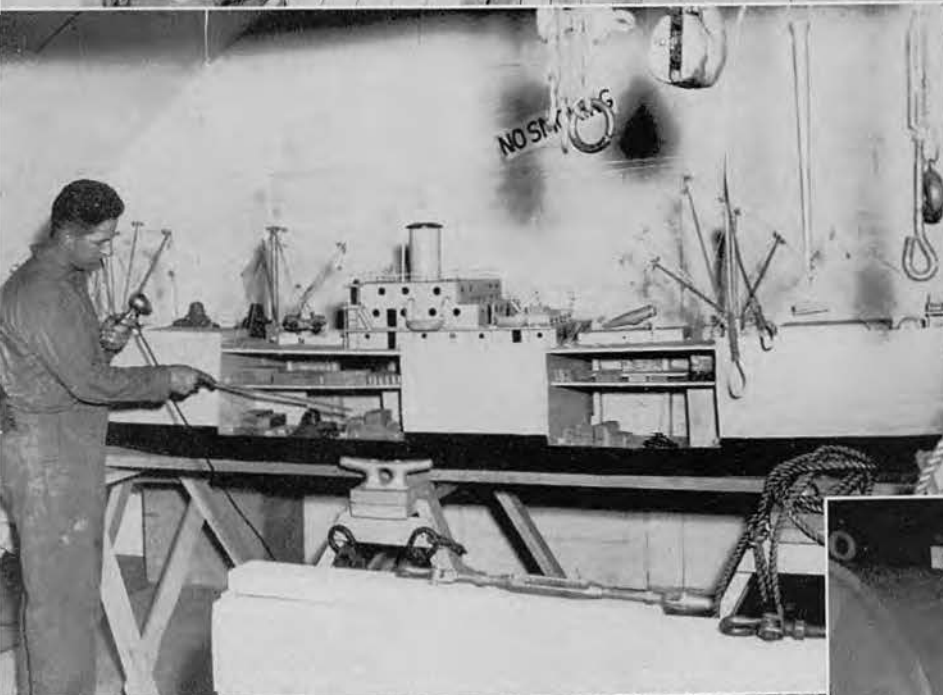
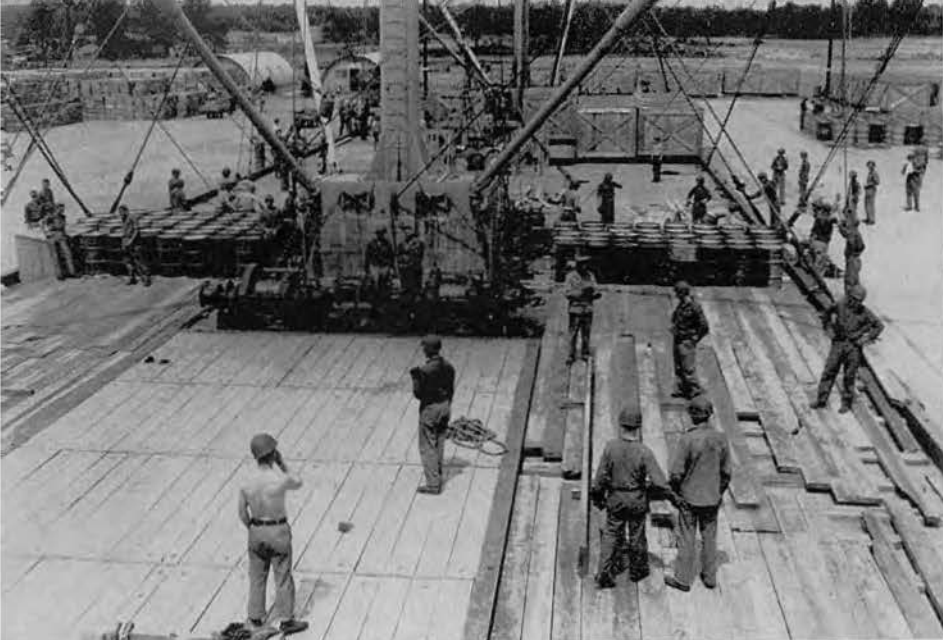
Camp Endicott, neat and compact, was to most men an improvement over Peary. Barracks were more comfortable. Recreation-Ship's Service buildings offered various opportunities for spending leisure time. It was but a short ride to Providence with its friendly people, its canteens, night clubs, and theaters. The New England countryside was attractive, but poison ivy brought long lines to sick bay. Boston and New York drew men for week-end liberty. But, of course, there was work as well as play. A provisional 33rd Battalion was formed and men were assigned to technical training courses. Then came a move to Sun Valley for six weeks of military training—rifle range, extended order, and bivouac. Life seemed rather free and easy, chow was good, and "Don't Fence Me In" was not yet a popular song.



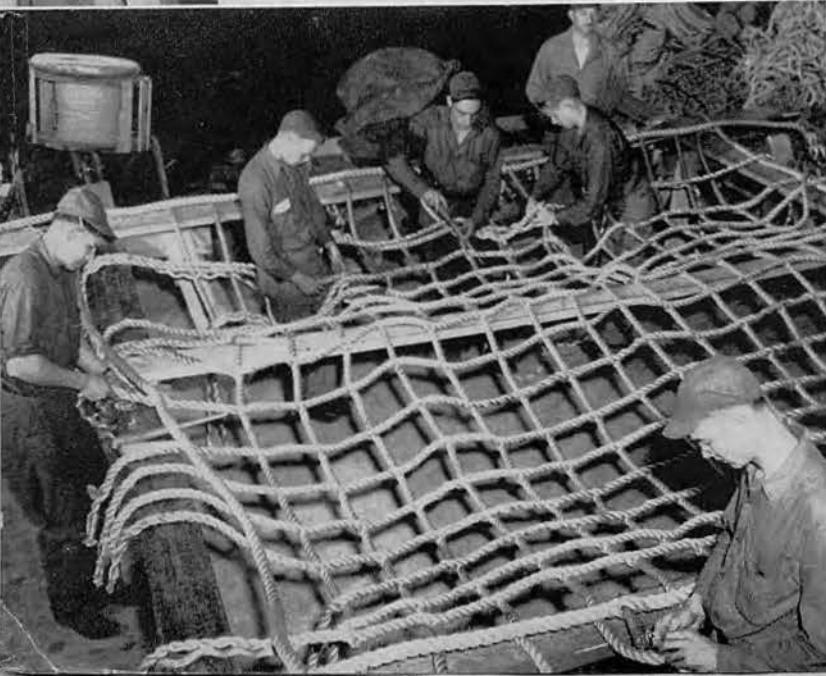
Coming of Age

Returning to Endicott for a busy month the men were given stevedore training. Meanwhile, the battalion had received its Officer-in-Charge and its Executive Officer and was soon to be commissioned. In a colorful ceremony on July 15, with officers and men in dress white uniforms, the battalion received its colors and marched in review before high Naval officers and civil officials. As the month drew to a close, time tables were studied and railroad tickets bought for the eagerly awaited embarkation leave which began July 30.



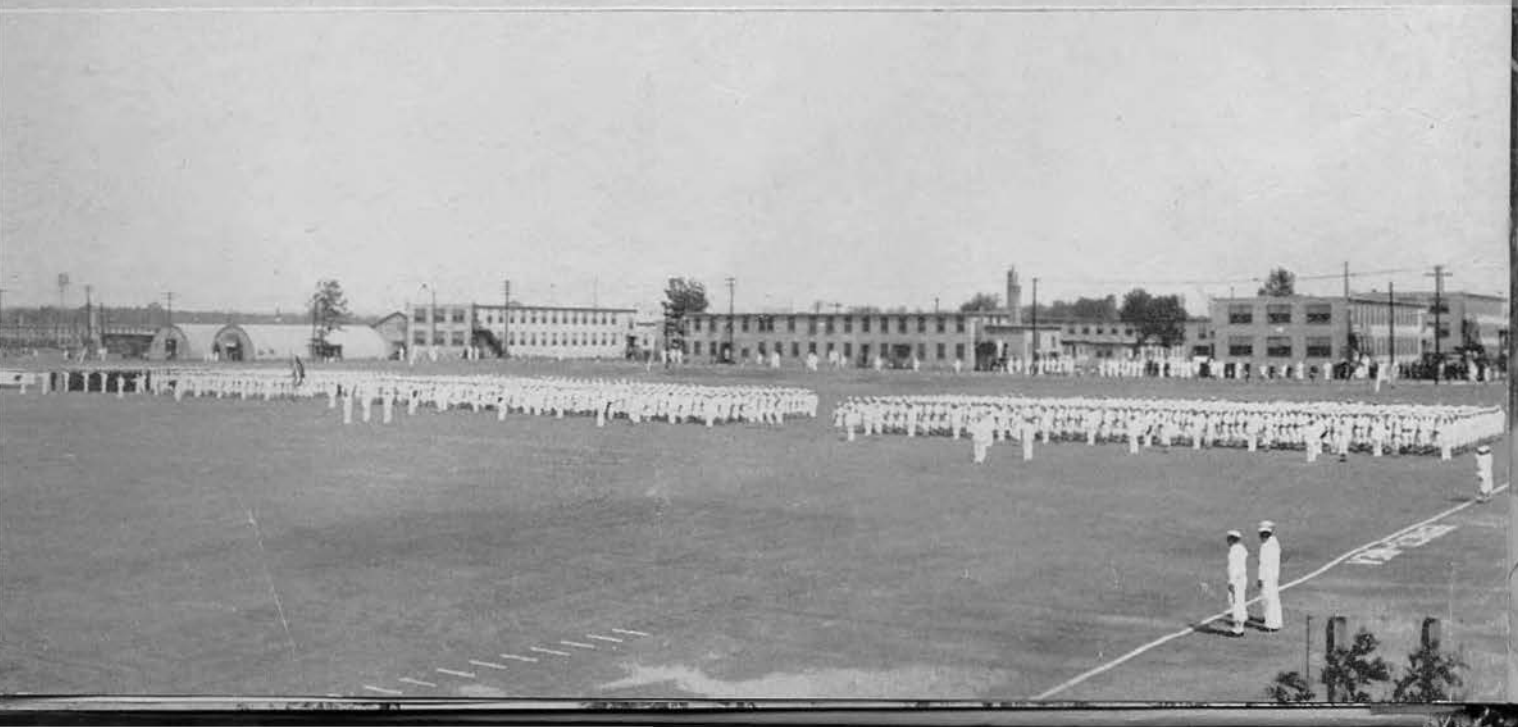
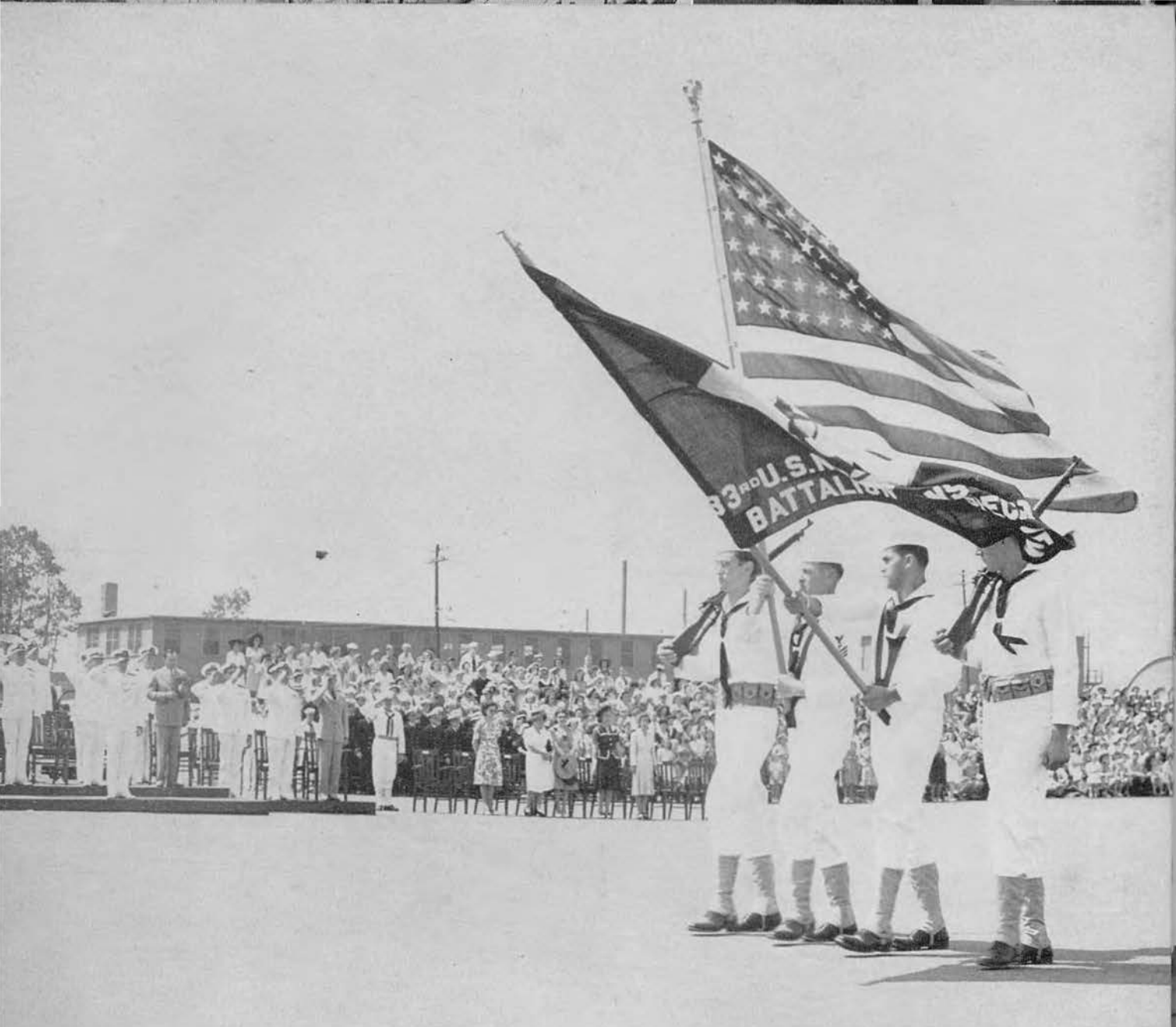


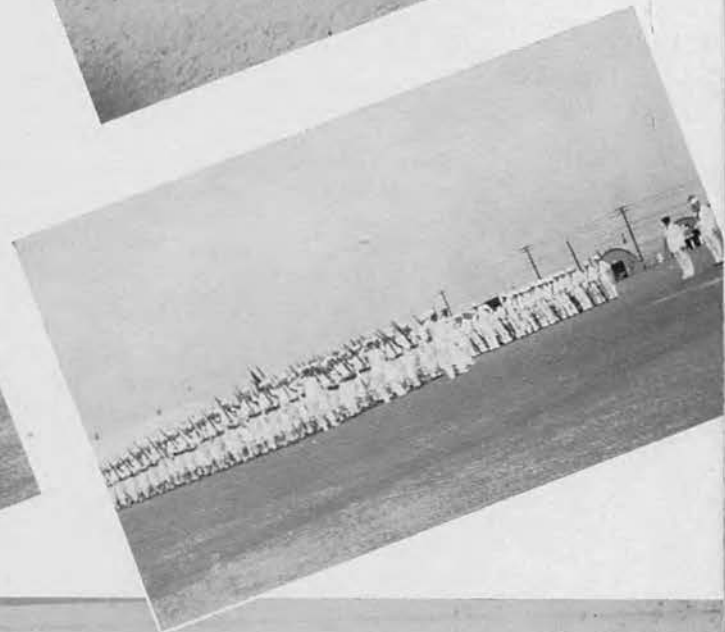
STEVEDORE TRAINING

At Sea....

A few days after the return to camp, the battalion moved to Camp Thomas. Rumor and speculation ran high. Would it stay there for any length of time or would it soon move? The answer was not long in coming. After making a notable contribution to the cleanliness of the camp, the men packed their gear and boarded troop sleepers for California.

Through car windows on the transcontinental trip could be seen something of the rich farming country of the Middle West, cities large and small, and the mountains and ranches of the West. Men played cards, read, and looked at the scenery. It made a pleasant change to have an occasional stop when they could get off the train and have refreshments served by a friendly group of people or have a meal in a restaurant. So the days and miles passed until Camp Parks was reached. The accumulated grime of the trip was removed and clothes were scrubbed and hung out to dry quickly in the intense heat. There was time for a liberty in San Francisco and a bit of clean-up about the area before moving on to Port Hueneme.

Here the Battalion lived on Easy Street, near the gate, the store and the library, enjoying, after a few days of mist and fog, the delightful California climate. Carbines, gas masks, and packs were issued; there was a course of military training; the stevedores were hard at work; battalion gear was assembled and packed; men were transferred in and out. Liberty meant going to fabulous Hollywood, to Los Angeles, Ocean Park or Santa Monica, with all their varied attractions and servicemen's facilities. Preparations went on busily and at length the day of departure came. On October 26, in groups of fifteen, with packs, carbines, gas masks, and seabags, men climbed into trucks for the ride to the docks. They filed up the gang plank and down into the hold for assignment to bunks. In a few hours the ship sailed and soon the shores of the United States faded from sight.

The ship was the M/S Torrens, a Norwegian cargo vessel with a captain and crew of that nationality, and now chartered as an Army transport. Rules were necessarily strict but often irksome. Water canteens and life preservers were carried at all times. Boat drills were essential routine as was the blackout. There was some kind of duty for all—clean up, security watch, gun crew, and the like. There were long lines for the two meals served daily in the mess hall. At noon came sandwiches with the inevitable spam. Sleeping quarters were crowded, the heat was unpleasant, and washing in salt water discouraging. Men played cards interminably on deck; they sat about reading or dozing; they leaned on the rail and gazed at the ocean expanses; they watched boxing matches and attended shows and movies.





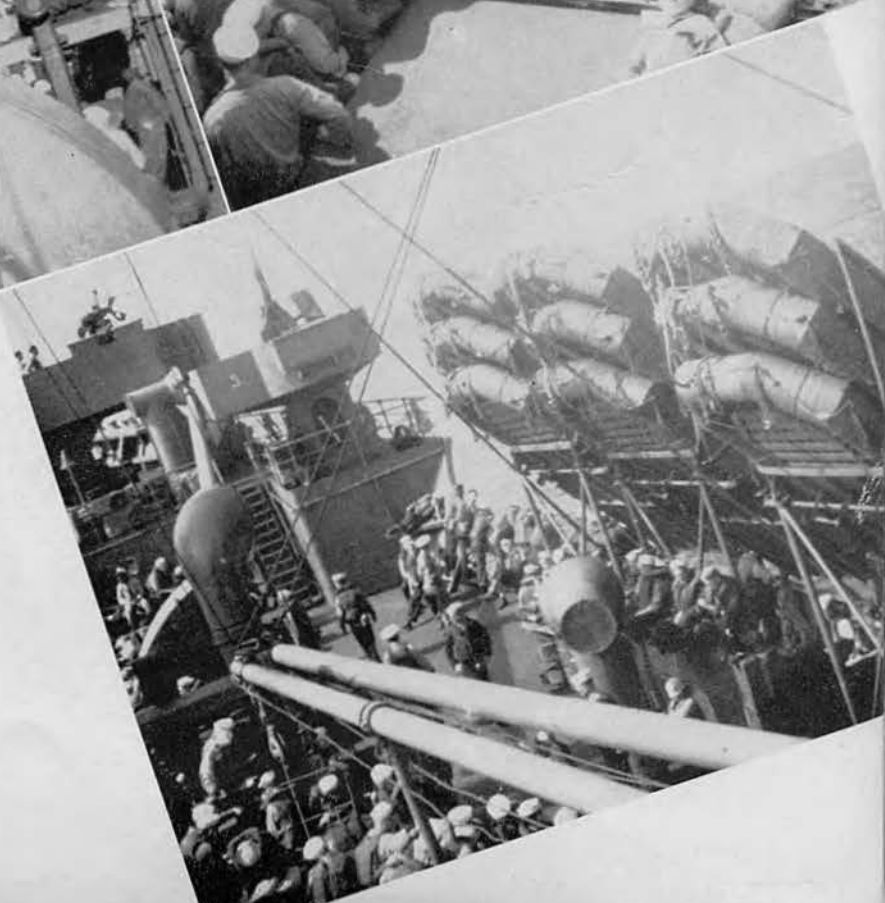
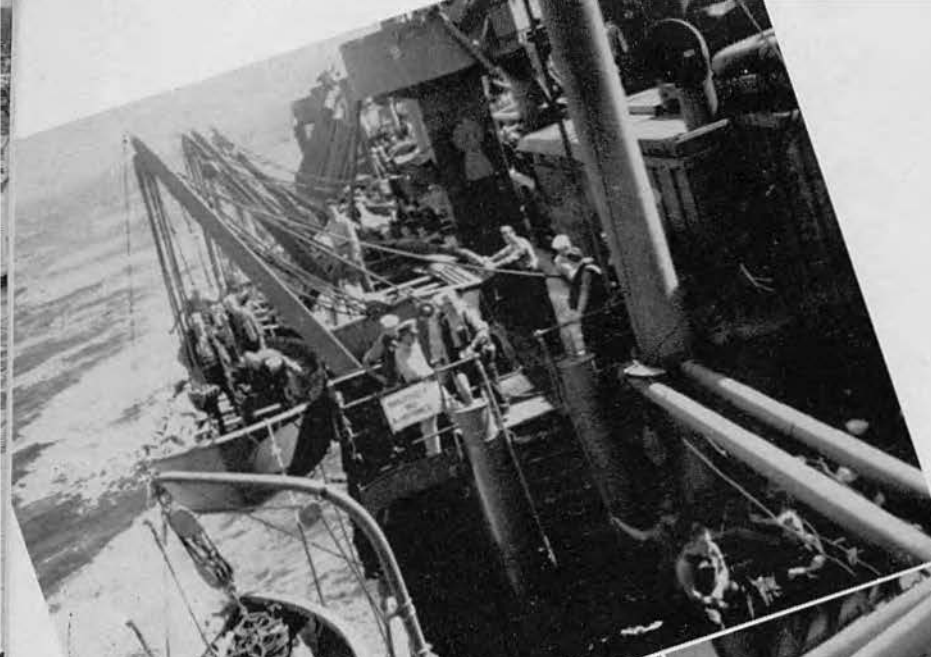

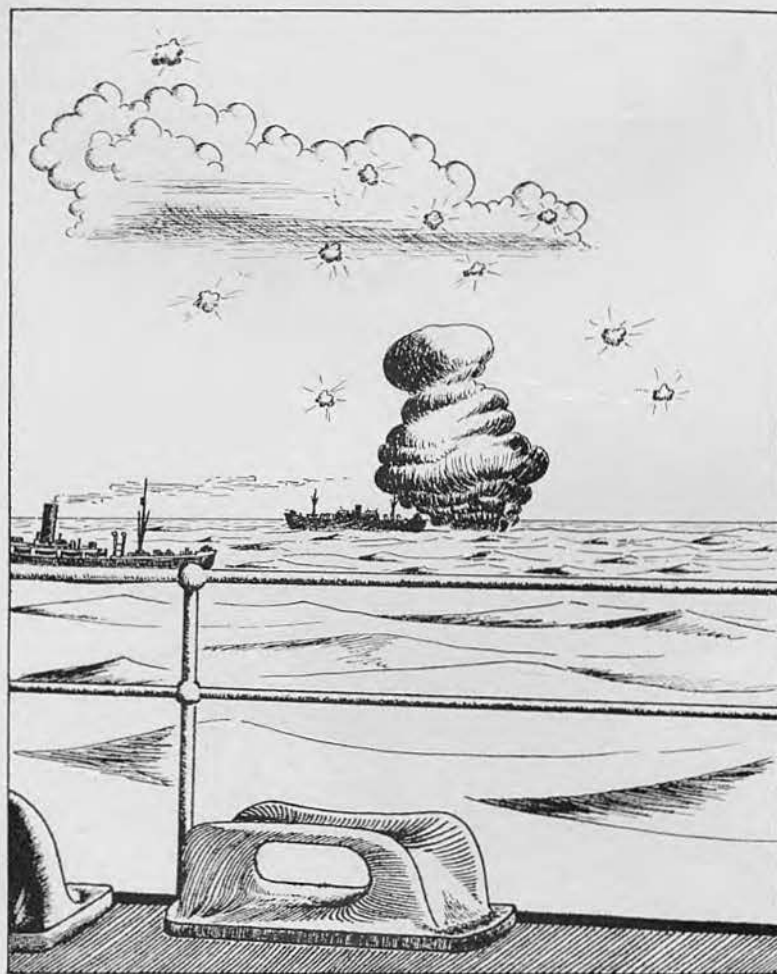

The destination was the subject of endless rumors and guesses. After a few days out, however, it seemed that the goal was Milne Bay, New Guinea, and after a fast voyage of fifteen days, the dark green jungles of New Guinea came into view. The ship docked and the men disembarked to be quartered in large receiving barracks. Then came the luxury of a fresh shower. There was the Coconut Grove for chow, a theater and a store nearby, and numerous opportunities to double one's money—or lose it. Letters from home were read eagerly. But in a few days, rumors again flew—another move was coming, to an area where there would be possible action, probably the Philippines.

Once more the 33rd boarded the *Torrens*, and made the two day journey to Hollandia. For ten days the ship lay at anchor in company with many others. As the heat became worse and the monotony of it all grew, men's impatience increased and they were eager to leave. At length a convoy formed and the slow trip to the Philippines began.

An enemy attack could be expected at any moment. Yet several days went by uneventfully while the convoy passed enemy held islands and neared its destination. Then one morning the warning bell rang before the regularly scheduled drill. Enemy planes were attacking! There were bursts of 20mm gunfire and occasional booms from the 3-inch guns. When the all clear sounded men rushed up on deck to see what had happened. All day the attacks continued. Damage was done to the convoy; some enemy planes were shot down. The *Torrens* received credit for shooting down one of them. The 33rd had seen action.

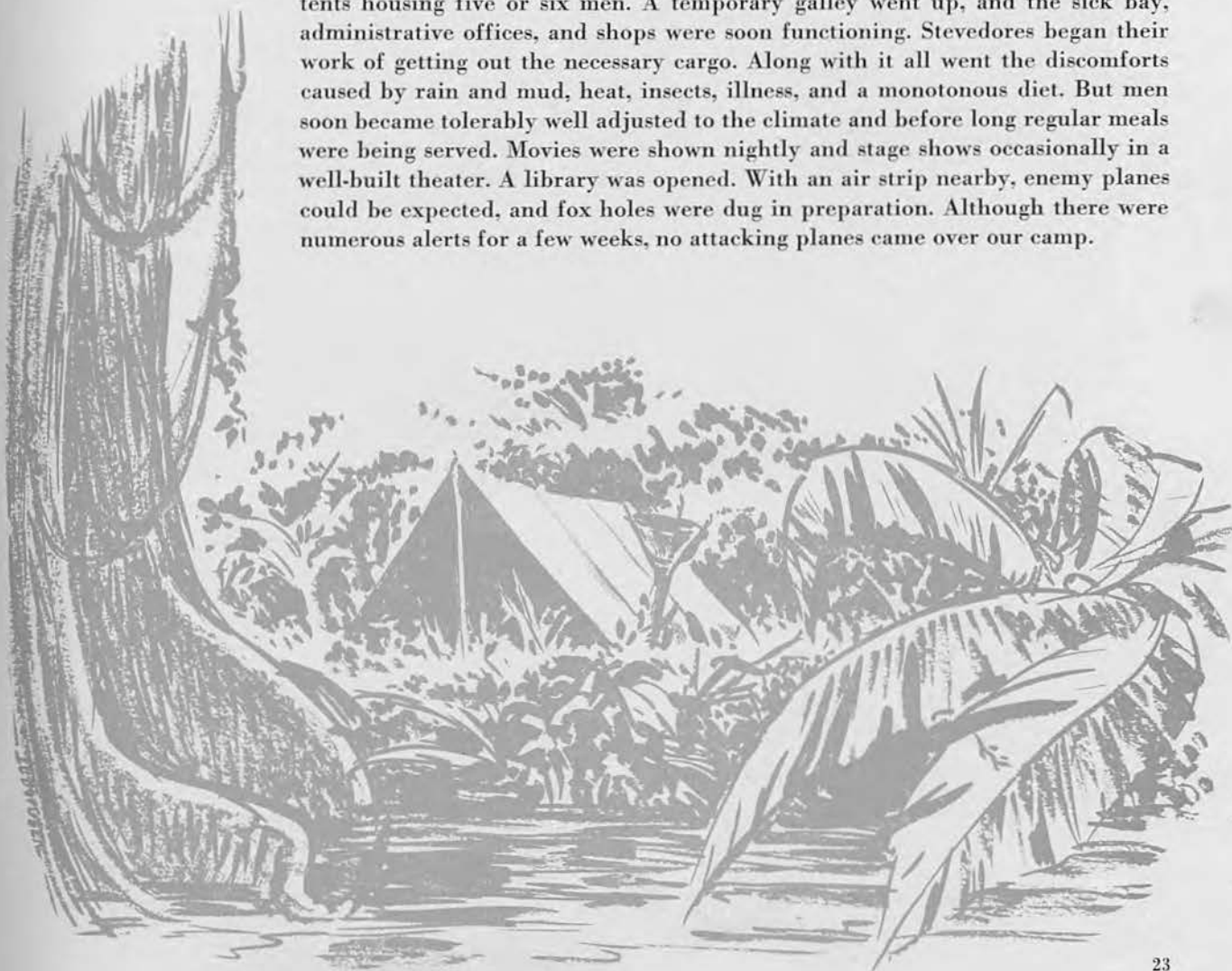

The First Camp

The next day the ship arrived at San Pedro Bay, Leyte Gulf. That night enemy parachute troops made an unsuccessful attack on shore installations. After a short stay the ship went on to Samar where the battalion was to land. On December 10, with full gear, men climbed down cargo nets into LCM's which took them to shore. Here was the town of Guiuan, ramshackle and poverty-stricken, with hordes of friendly natives eager to do a bit of trading.

Then, falling in, the men picked up their gear—or hired a native porter—and followed the Officer-in-Charge through town and up the road. At length came the order to halt and each company was assigned a camp area. Underbrush was cleared away and pup tents were put up. There was an air raid alert. Long lines formed on the road for chow—spam, biscuits, and fruit juice. The menu varied little for several days. Men walked a mile for water.

So the job of building a camp began. Pup tents were replaced with pyramidal tents housing five or six men. A temporary galley went up, and the sick bay, administrative offices, and shops were soon functioning. Stevedores began their work of getting out the necessary cargo. Along with it all went the discomforts caused by rain and mud, heat, insects, illness, and a monotonous diet. But men soon became tolerably well adjusted to the climate and before long regular meals were being served. Movies were shown nightly and stage shows occasionally in a well-built theater. A library was opened. With an air strip nearby, enemy planes could be expected, and fox holes were dug in preparation. Although there were numerous alerts for a few weeks, no attacking planes came over our camp.

Chow is always important and never more so than in the morning. Standing in line is second nature to a Seabee. This morning it's for hot-cakes



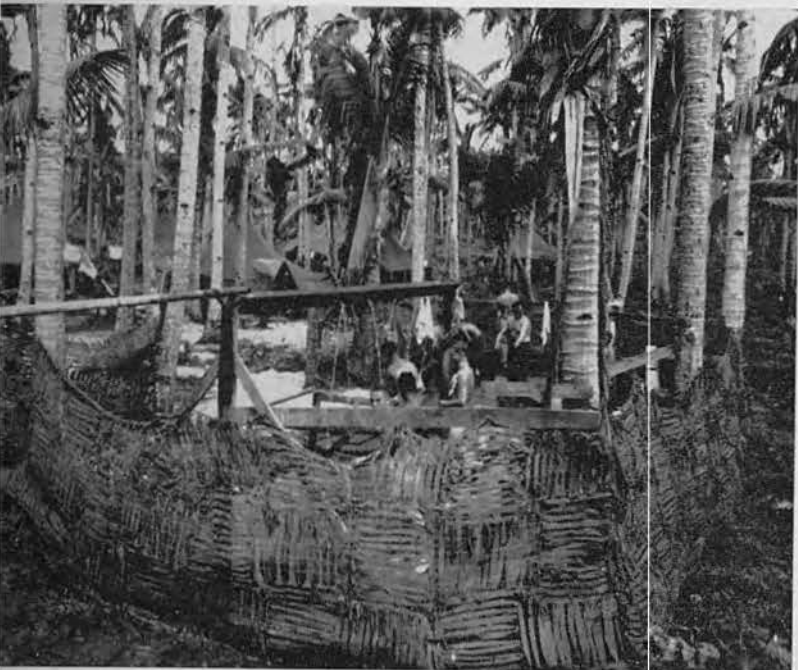
The Flag goes up in the Philippines as on all other fronts. It's 0700. Breakfast is over and work begins.

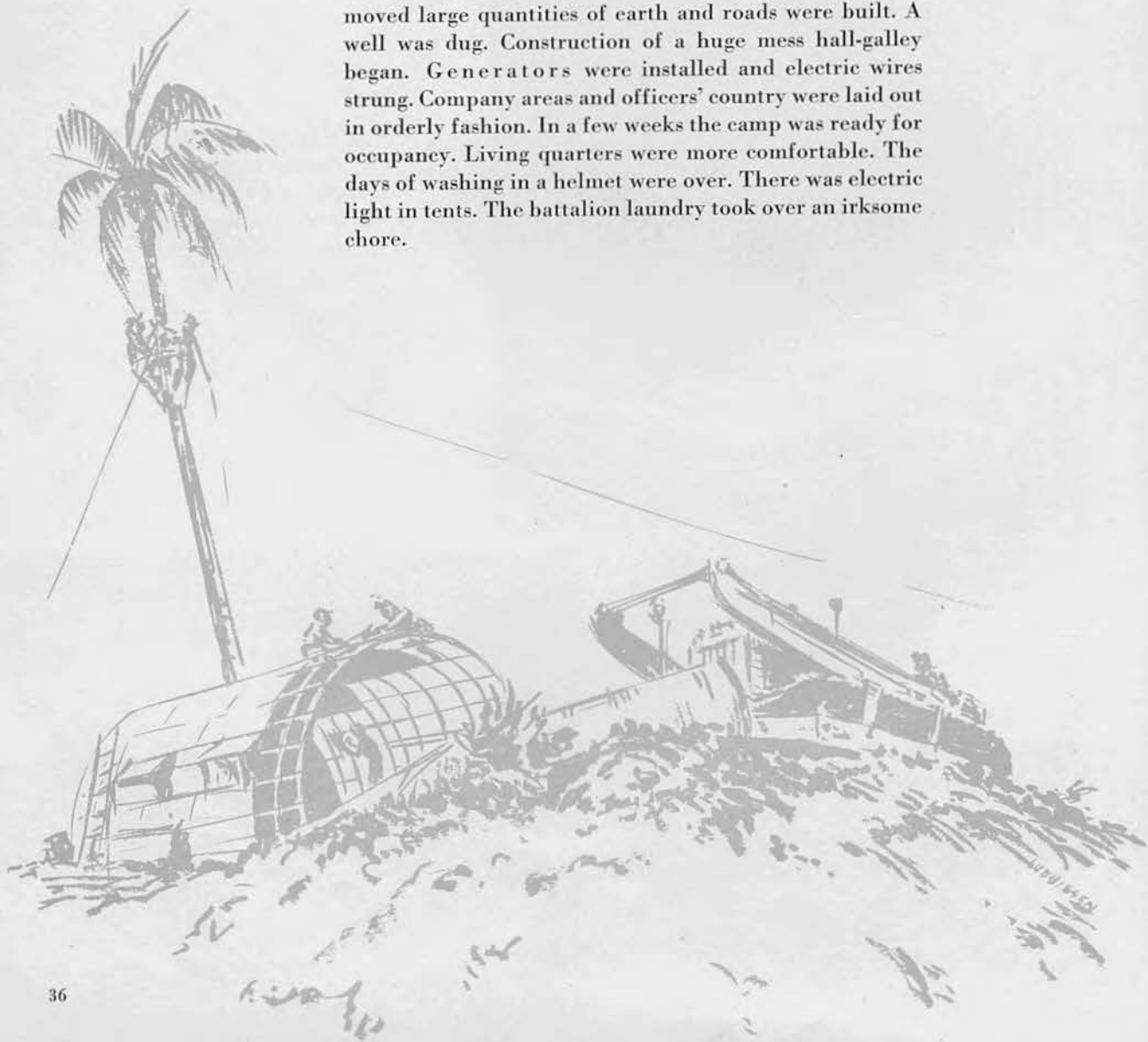

The Second Camp

There were always rumors one after another: the battalion would move to a forward area, it would stay, it would relocate on Samar. Then in March the battalion was assigned a new campsite a few miles from the old one, and the work of building a camp began. Although a stevedore battalion, the 33rd had many men with skilled trades—carpenters, plumbers, electricians, and the like—and officers with experience in supervision. Bulldozers moved large quantities of earth and roads were built. A well was dug. Construction of a huge mess hall-galley began. Generators were installed and electric wires strung. Company areas and officers' country were laid out in orderly fashion. In a few weeks the camp was ready for occupancy. Living quarters were more comfortable. The days of washing in a helmet were over. There was electric light in tents. The battalion laundry took over an irksome chore.
